		side of the face.
		Runner reported having felt properly looked after by the group leader and that the incident was dealt with
		very well.
11.04.17	4	Fell and suffered a few small cuts and bruises. Felt ok but one of the group offered to walk/jog back with
		runner. The group was within a mile of the rec and all got back to the Rec safely.
22.04.17	Beg	Fell and suffered grazing to hands and one knee. Able to continue.
13.06.17	7	Fell in Scadbury Park and suffered cuts and grazes. Able to continue.
27.06.17	9	Slipped on manhole cover near footbridge. Able to continue.
01.08.17	1	Fell, bumped head and grazed elbows. Another runner accompanied runner home and waited until
		another person arrived home.
01.08.17	7	Calf strain. Injured runner was accompanied back to Willett Rec. NB 31 runners in group!
15.08.17	3	Tripped over raised paving on Kingsway, grazed hands and knees. Continued to Willett Rec.
22.08.17	7	Tripped and twisted ankle. Continued running but ankle was bruised and swollen later on.
22.08.17	8	Tripped and fell
29.08.17	7	Tripped over own feet and fell, grazed knee. Able to continue although the group stopped a couple of
		times to check on runner.
26.09.17	3	Tripped and fell. Sustained grazed knee and possible sprained wrist. Able to continue. Later reported to
		H&S officer that wrist was fine.
31.10.17	2	Tripped on raised paving slab. Suffered sore hand and grazed knee. Able to continue
31.10.17	8	Suffered recurrence of old knee injury and couldn't continue. Karen accompanied him to bus stop in

		Orpington High Street.
31.10.17	8	Group leader suffered calf muscle tear and was unable to continue. Group stopped and one member went to fetch car to bring leader back to Willett Rec (or more accurately One Inn The Wood). Another runner – a regular group leader – took over for the remainder of the run.
