# 2. Return to club runs (RD / NM)

Permitted to return to organised group runs come 29<sup>th</sup> March. Unlimited numbers allowed. Noted no of leaders could be an issue and agreed some may be reduced to 1 group. Agreed start with 6 but would regularly review

Create a "return to running group" HH and RD to assist Donna to arrange.

COVID rep not required agreed to add to leader's page rules of COVID to remind them the checks and responsibilities

Discussion on whether the LIRF course should still be a requirement for our leaders this is due to many new leaders joining during COVID and not LIRF qualified and to consider whether to no longer be mandatory.

RD confirmed that the leaders were still insured without LIRF. GS raised – Are our leaders required to have a DBS check before leading? DBS gives security/confidence of checking individuals. **HH** to check safeguarding policy. All agreed DBS was essential.

**DS** agreed to contact EA to find out if we can do our own in-house course and still have the subsidised DBS check. **RD** to feedback on effectiveness of online course

# 3. Petts Wood 10k including Race Director role (NM)

Agreed PWR 10k race to be 10<sup>th</sup> October despite clash with Manchester Marathon Race Director to be advertised before AGM – Via email and Facebook **(DS)** NOTE both Joanne and Stephen confirmed they would be stepping down from re-election to the committee at the AGM
